By signing below, I agree that I will take responsibility for inspecting and insuring the safety of the participant, meeting, and other areas and facilities within Iglesia Comunal La Esperanza and the Florida District of the Fellowship of Grace Brethren Churches in Winchester, Virginia. I hereby release, waive, discharge, and covenant not to sue Iglesia Comunal La Esperanza and the Florida District of the Fellowship of Grace Brethren Churches, its pastors, elders, trustees, members, employees, operators, promoters, officials, sponsors, advertisers, other participants, and any and all other persons in or upon the athletic facilities, spectator area, playing field or grounds of Iglesia Comunal La Esperanza and the Florida District of the Fellowship of Grace Brethren Churches (all of whom for the purposes herein are referred to as "the Releases"). In addition, I release the Releases from all liability to me or my personal representatives, assigns, heirs, and the next of kin for any and all damages, and any claims thereof, based upon my participating in, viewing, or attending any event at Iglesia Comunal La Esperanza and the Florida District of the Fellowship of Grace Brethren Churches.

I further expressly agree that this Release, Waiver of Liability, and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the laws of the Commonwealth of Virginia, and that if any portion thereof is held invalid, I agree that the balance of this document shall, notwithstanding, continue in full legal force and effect.
